MILESTONES

1905 Sets up first textile mill in India by our founder Mafatlal Gagalbhai

1912 Sets up a second textile mill in neighbouring India

1916 Sets up third mill in India

1919 Shifts base to Mumbai with the purchase of a textile mill.

1931 Establishes fifth textile mill in India.

1944 Shri Navinchandra Mafatlal takes over the family business.

1945-54 Group invests heavily in cotton textile mills and their modernization to become the third largest mill owner in India. Establishes a strong foothold in over seas market

1954 Mr. Arvind Mafatlal takes over the reigns of the group companies and starts diversification of the group business

1970 Mafatlals promotes ace cricketers and football players and gains tremendous mileage

1979 After division of the Mafatlal Group business, the Arvind Mafatlal Group focuses on textiles, petro chemicals, rubber chemicals and fluoro chemicals.

1980-90 Consolidates its position in textiles, expanding the textile machinery activities.
Mr. Hrishikesh Mafatlal takes over the reigns of the company

1996 Joint Venture (50% - 50%) with Burlington Industries, USA called Mafatlal Burlington Industries Ltd. for manufacturing denim fabric.

2006 Paved a new path to success by acquiring entire stake of Burlington, USA to set up Mafatlal Denim Ltd.

2009 Mafatlal Denim establishes itself as the largest supplier of denim material in India, and as a reliable supply chain partner for value added and fashion denims across the world

2012 Launches home furnishing range with terry towels and bedsheets.

2013 Group modernizes its mills once again.

2013 Mafatlal Denim Ltd Amalgamated with Mafatlal Industries Limited.
